## Public Access: Reinstate and Renew a Corporation License

This How-To-Guide is intended for office managers who are responsible for the reinstatement and renewal of a corporation license.

1 Login and navigate to your **public dashboard**. Under the "**My quick links**" section of the dashboard, Locate and click the "**Edit Corporation**" button. Note: If you manage more than one corporation, Click on the **down arrow** to display a list of corporations you are assigned to and select the corporation you want to reinstate. Click "**Edit Corporation**".
